Additional comments provided on the adoption status?	<p>Article 54 of the Afghanistan Corporations and Limited Liability Companies Law states:</p> <p>ARTICLE 54: Preparation and Delivery of Financial Statements:</p> <p>(1) Not less than 15 days prior to the Regular/Annual Meeting of the Shareholders, the Corporation shall deliver to all of the Shareholders entitled to attend such Meeting Financial Statements dated as of the last day of the fiscal year of the Corporation, which shall include the balance sheet dated as of the last day of the fiscal year and the profit and loss statement of the Corporation for the fiscal year. The Central Bank has prescribed IFRS Standards.</p>
