IASC Foundation XBRL Team Status Update

Executive Summary

The new IFRS Taxonomy 2008 has been circulated in draft to XBRL Quality Review Team (XQRT) and is now in the review phase. An Exposure Draft will be published by end of March.

1 Update on IFRS taxonomy development

As stated during previous Trustees' meetings, the XBRL team initiated a full redevelopment of the IFRS Taxonomy. The IASB Technical Staff has been involved in this effort.

As planned, a **first draft of the new IFRS Taxonomy 2008** has been circulated to XBRL Quality Review Team (XQRT) and is now in a three-week review phase. Until now, the XQRT has yet to raise a significant quality issue. An **Exposure Draft** for general public comment will be published by the end of March for a 60-day comment period.

The **Final Version** of the IFRS Taxonomy 2008 should be published by the end of June.

3 Update on Advisory Council and Quality Review Team

3.1 XBRL Advisory Council (XAC)

3.1.1 Outcome of the XAC conference call on 20 February 2008

The main topics discussed by XAC members during the conference call on 20 February were:

 - iii. The Final Version of the IFRS Taxonomy 2008 will be published not later than the end of June.

- Adoption and implementation of IFRS Taxonomy and the role of XAC members
